Proposed "Security of Payment" Legislation for Construction Industry Stakeholders Forum

香港的建造業規模龐大、多元化，因此分判作業模式在本地建造業甚為普遍，因而引至容易出現爭議及拖延付款等問題。跟據發展局調查的結果顯示，香港建造業的付款問題嚴重，單憑公共工程合約的行政和合約安排，並不能解決整體業界的問題。因此，發展局認為有需要立法，處理建造業的付款問題。我們將展開為期三個月的公眾諮詢，並於諮詢會上介紹諮詢文件的內容及聽取意見，誠邀業內人士及相關持份者參與。

Hong Kong has a large and diverse construction industry undertaking a wide spectrum of work. It is also evident that sub-contracting is a prevalent practice in the local construction industry with its vulnerability to disputes and payment delays. According to the DEVB Survey, there are widespread payment problems in Hong Kong's construction industry and with the administrative and contractual arrangements on public works contracts alone cannot help resolve the problems of the wider industry. DEVB therefore consider it necessary to adopt a legislative approach to address payment problems in the industry. During a three-month consultation period, we would like to seek views from the industry and public to enable Government to develop the optimum SOPL in Hong Kong. We cordially invite industry stakeholders to attend the Forum to get a holistic view on the consultation document.
